## Subject: Display of Testing Charges by TEC Designated CABs on their Website

- Ref: 1. TEC letter dated 04.07.2019 for launch of 1st Phase of MTCTE
  - 2. TEC letter dated 23.06.2020 for launch of 2<sup>nd</sup> Phase of MTCTE
  - 3. TEC letter dated 24.06.2020 for revision of provision in MTCTE Procedure - Acceptance of test results/ test reports from labs accredited by ILAC

Reference is invited to TEC letters dated 04.07.2019, 23.06.2020 and 24.06.2020 mentioned above for launch of MTCTE Phase-I, Phase-II and for acceptance of test results/test reports from labs accredited by ILAC for MTCTE.

2. In this context, it is brought to your kind notice that in continuation to Implementation of Phase-I of MTCTE w. e. f. 01.10.2019, Phase-II of MTCTE is also going to become mandatory with effect from 01.10.2020. Further vide letter dated 24.06.2020, test results/test reports in respect of **Safety Requirements and EMI/EMC Requirements** under Essential Requirements available on MTCTE Portal should be certified by TEC Designated Domestic Conformity Assessment Bodies (CABs) only.

3. As a result of implementation of Mandatory testing, a number of OEMs/Manufacturers have come forward for the testing of their telecom products and have approached TEC regarding testing charges by TEC Designated CABs in Public domain i.e. on their website.

4. This issue has been examined and I have been directed to convey that all Designated CABs of TEC should display the testing charges for different types of testing on their website. This will create a more transparent and conducive environment for seamless implementation of MTCTE.
