Sub: Utility Agencies for Call Before U Dig (CBuD) Apps- reg

Sir,

Department of Telecommunications has come out with "Call Before U Dig" Mobile App for addressing the issues of coordination between excavation agencies and asset owner agencies. For the roll out of this app in the state of Arunachal Pradesh it is mandated that:

1. All works departments involved in the excavation shall appoint a "State Department Admin/Nodal" officer to operate their Admin account to create user admin of utility agencies under the respective department, named as "State utility agency Admin/Nodal" which shall create sub users in their respective agencies – area/district wise with the contact details – Email and Mobile Number, office landline number etc.
2. Once CBuD is activated, all digging agencies prior to any digging, will have to intimate their digging activity on the CBuD app.
3. Your Department has to ensure that all utilities lying under the ground are mapped on GatiShakti portal.
4. Your Department also has to ensure that all Digging Agencies are registered on CBuD App.
5. The Guidelines issued by Secretary (Telecom), GoI are enclosed herewith for detailed information and guidance.
