

“Call Before u Dig” (CBuD)

Mobile App

An app of Government of India to prevent damage to underground infrastructure due to unplanned excavations

Various agencies often undertake excavation activities and many times underground utility assets get damaged



This may be due to lack of knowledge of excavation agencies about existing utilities or lack of coordination with utility asset owner agencies



To provide an interface and communication channel between

- Excavation / Digging agencies
- Utility Asset Owners



To coordinate for proposed excavation/digging activities and to safeguard existing underlying utility assets like Optical Fibre Cables, Water Pipelines, Electric Cables, Gas Pipelines etc. from damages

CBuD App: Features



“Call Before u Dig” CBuD – Mobile app can be downloaded on android & iOS devices



Excavator can submit excavation/digging plan and know contact details of utility asset owners for coordination before start of excavation



Utility Owners – will get details submitted by excavators about excavation activity, know contact details of excavator and interact with them.



Excavators/utility asset owners will be given alerts via SMS, email and in-app notification and will also have the facility of **‘click to call’**.

CBuD App: Advantages



Govt.

- Many utilities can be saved from unwanted cuts and wasteful expenses for restoration



Utility Asset Owners

- Owners of all the utility assets can come to know about imminent digging by any agency around their utility assets and take precautionary measures.
- The app will allow for scheduled digging and uniformity of processes.
- Automated Email, SMS and in-app alerts for better coordination with the excavator.



Digging Agencies/Excavator

- The app will allow the digger to submit all the required information to all the utility asset owners at one place.
- Diggers need not spend time finding contact details of different utility providers.
- The centralized facilitation desk would offer a one-stop solution for all queries related to usage of the Mobile App.
- The electronic circulation of the dossiers will save time for both the diggers and utility asset owners and public administration and would make the digging process damage-free.
- The diggers through an easy-to-navigate and user-friendly interface will be able to track the status of their requests.



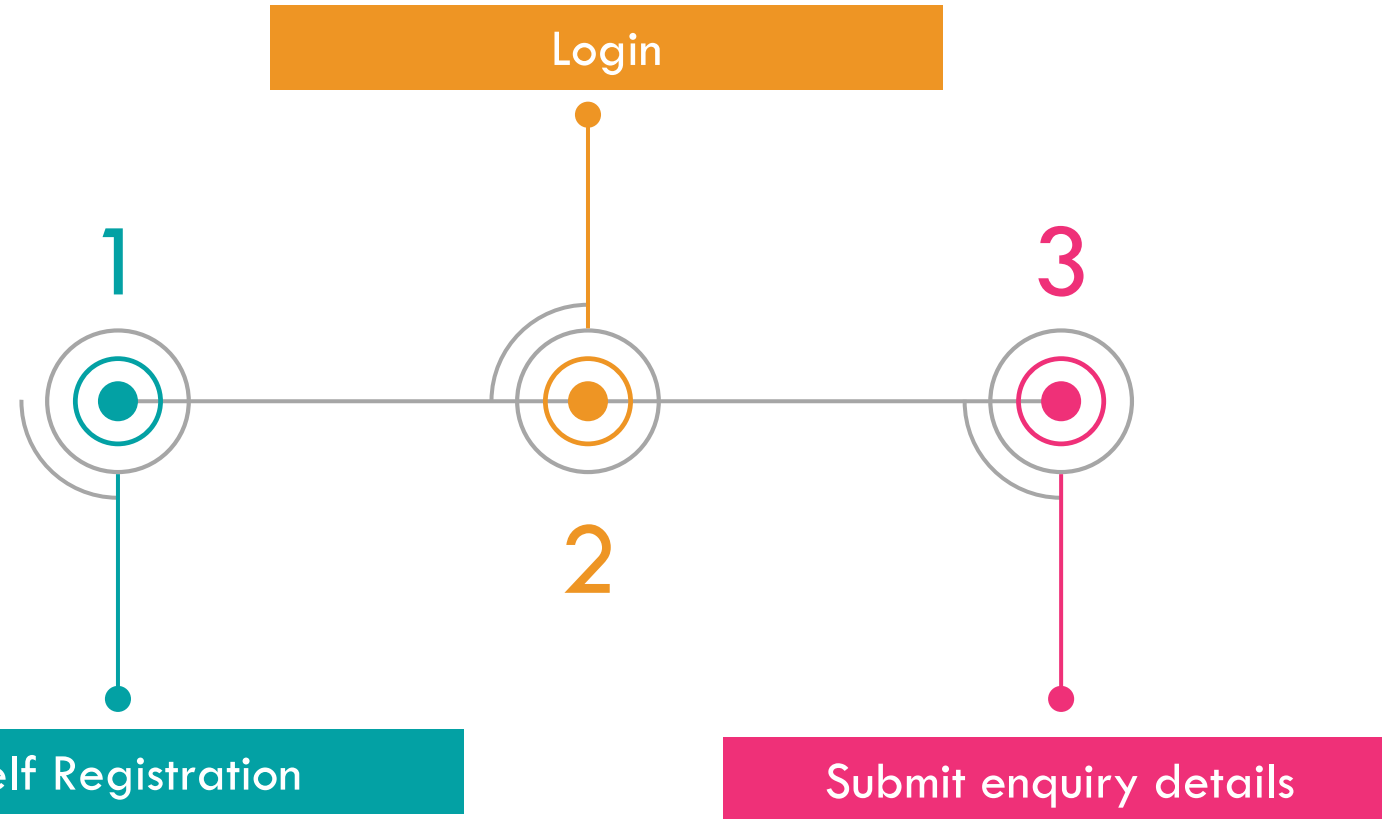
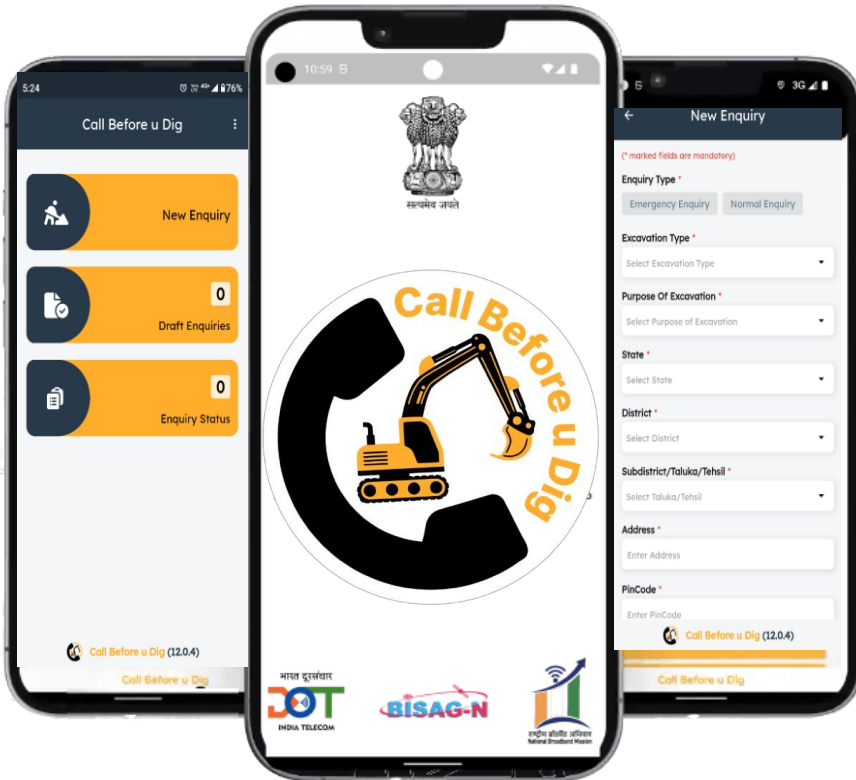
Citizen

List of Asset Owners and Acknowledgment Status will be shown

- ▶ **All underground utility/asset owner agencies viz. Electricity Cables, Water-pipe, Gas-pipe, Sewerage etc. to be directed by State /UT Govt:**
 - to map contact details/ escalation matrix in the “Call Before u Dig” App for receiving SMS/email notifications.
 - to be mandated to respond to messages from the “Call Before u Dig” App and take actions accordingly, even if they have mapped or not mapped their assets.
 - to register their assets on PM GatiShakti National Master Plan (NMP) Platform.
- ▶ **All digging agencies to be mandated by the State / UT Govts:**
 - to do any type of digging only after prior intimation through “Call Before u Dig” App and as per its terms and conditions.
 - to use the App before commencing any type of digging anywhere in the State / UT
- ▶ **All State /UT departments to be directed to include Point 2 in the approval letter format, while granting approval for any type of digging anywhere in the State**
