Sir/Madam,

With reference to the subject cited above, I have the honour to inform you that the Department of Telecommunications, Govt of India, has rolled out an initiative named "**Call Before u Dig**" (CBuD) Mobile App. This initiative seeks to minimize the damage to existing utilities caused by repeated digging of roads by utility providers like water, telecom and electricity services providers etc.

Therefore, you are requested the following:

1. To instruct agency/ contractor under your department to register on "**Call Before u Dig**" App.
2. To provide prior intimation through "**Call Before u Dig**" App before excavating on public land/roads in the state by your department/any agency/ contractor under your department.
3. The Work Order of the Department shall include "Agency which is excavating must use the CBuD App before commencing any excavation on public lands/roads in the State" as a mandatory clause/condition.
