Terms and Conditions

- 1. This certificate merely indicates conformance to the Essential Requirements (ER) mentioned therein in MTCTE certificate and the actual use of this telecom equipment is subject to the applicable rules and regulations as in prescribed by DoT from time to time.
- 2. This certificate does not cover any functions or features beyond the scope of the TEC specification mentioned therein.
- 3. This telecom equipment has been tested and certified to meet out the intended objectives of Mandatory Testing and Certification of Telecom Equipment regime viz. i) telecom equipment does not degrade performance of existing network to which it is connected, ii) safety of the end-users, iii) protection of users and general public by ensuring that radio frequency emissions from equipment do not exceed prescribed standards, iv) telecom equipment complies with the relevant national and international regulatory standards and requirements.
- 4. This certificate as issued by TEC, shall not be valid for any hardware variant of this telecom equipment. Any hardware variant of this telecom equipment shall be treated as a different model for which a fresh certificate or modification in certificate shall be required. Modification of certificate shall be governed by the provisions contained in MTCTE procedure.
- 5. The software version mentioned in this certificate was the version declared by the certificate holder at the time of testing of the telecom equipment. Applicant shall ensure that change in software version does not affect the conformance of the certified product to its ER. Further, instructions of Security division of DoT w.r.t to change in software version, if any, shall be adhered to.
- 6. The certificate holder shall ensure that this telecom equipment/product continues to conform to the respective Essential requirement against which the telecom equipment was last certified.
- 7. If there is any modification in this telecom equipment/product, applicant shall apply for modification in certificate in accordance to the provisions contained in MTCTE procedure well in advance.
- 8. If the telecom equipment/product has not been tested and certified against Security Requirements, then, Security Requirements, whenever notified by the Security Wing of DoT, shall become part of the Essential Requirements. The telecom equipment may be required to get tested and certified against Security Requirements in accordance to the instructions of DOT.
- 9. During the validity of this certificate, TEC reserves the right to inspect and/or test the product/equipment at any premises where it is in use or at the place of the manufacturer. If any adverse effect/deterioration in the conformance to the Essential Requirement is

- noticed during inspection and/or testing or its use in Indian telecom network, provisions of non-conformity and contravention may be invoked.
- 10. For radio communication equipment, the operating frequencies shall comply with the approved frequencies by Wireless Planning and Co-ordination (WPC) wing of Department of Telecommunications. Possession, use, sale and operation of the wireless equipment/product is subject to applicable permissions/licenses.
- 11. TEC may amend/suspend/cancel this certificate in view of Government orders and rules or any anomaly noted by TEC/RTEC.
- 12. For renewal of this certificate, the certificate holder must apply online and pay the renewal fee, at least one month prior to expiry of its validity period.
